

## PERMANENT ISSUED GOVERNMENT AGENCY TAX EXEMPTION CERTIFICATE NUMBERS

Below is a list of some of the common local government agencies with tax exemption numbers. If one is not listed and they don't know their number, please contact the City and Borough of Sitka Tax Division.

Government agencies are exempt from sales tax.

Bed tax is only exempt if paid by government issued credit card. State and federal governments are exempt from this tax through purchase order or other device (government credit card) obligating the government to pay for the room. Government employees are not exempt from this tax if the room is rented to them individually or they have the ultimate obligation to pay for the room.
