He mentioned this ordinance was to improve the permit process to include expansion of the definitions, establishing regular public engagement to establish carrying capacities and land use guidelines, empowering staff to review and issue permits, establishing a new process for application, public comment and other administrative guidelines.

The Committee discussed the potential for raising fines for operating without a permit in special use areas and sought to clarify the language concerning permit transfers and credit payments in the commercial recreation ordinance.

Prussian move to recommend approval to the Assembly on the Commercial Recreational Use Permit Ordinance. Motion passed unanimously 6-0.
