# Taylor moved to approve September 9, 2024 minutes, with Section VII. Item B as amended by Commissioner Riley.

#### VII. NEW BUSINESS

### A. Discussion/Direction/Decision on the Sitka Community Renewable Energy Strategy (SCRES) Workshop to Develop Future Energy Scenarios

Sarah Troise from the SCRES technical presented on the draft SCRES workshop. Commissioners discussed various considerations and improvements that could be integrated into the workshop. The Commission indicated the desire to pilot test the workshop to provide better feedback. Gabel informed the Commission of their options to do so and would schedule pilot groups accordingly.

Eric Jordan suggested to keep it as simple as possible and insisted on a higher sense of urgency.

### B. Discussion of EV Transit Van Procurement for the Parks and Recreation Division

Gabel introduced the item and explained that the preliminarily lifetime cost analysis of an EV Transit van and a traditional internal combustion engine (ICE) transit van were nearly identical but lacked additional considerations beyond monetary cost estimates. She requested the Commission add their opinion so it could be incorporated into the supplemental appropriation that would be necessary to go the Assembly for the final decision. Gabel and Kevin Knox, Parks and Rec Coordinator answered Commissioners' questions regarding the procurement process and specifications of the van's requirements and intended use.

# Hope moved to support the procurement of an electric transit van for the Parks and Recreation Division.

### Motion PASSED 5-0 by roll call vote.

Riley, Taylor, and Hope volunteered to review the memo that would be included in the supplemental appropriation.

Gabel called attention to the Decarbonizing and Rightsizing to Improve Vehicle Efficiency (DRIVE) Advisory Group and the role Sustainability Commissioners could have in answering these questions outside of Commission meetings about other vehicle procurements. She inquired about Commissioner interest in volunteering to sit on the DRIVE Advisory group; Riley and de Jong volunteered.

### Subject: Discussion on Sustainability Commission 2025-2026 Goals

### **Background**

On March 26<sup>th</sup>, 2024, the Assembly <u>unanimously approved</u> the goals of the <u>Sustainability Commission</u> <u>2024-2025 Work Plan</u>. These goals are:

- 1. Continue the development of the Sitka Community Renewable Energy Strategy (SCRES)
- 2. Collaborate with City staff on strategic management of municipal solid waste (MSW)
- 3. Support electrification of the municipal fleet

Like the 2023-2024 work plan, goals were targeted sequential, and the effort of the Commission was focused on goal 1 until there was a lull, when the Commission would begin focus on the next goal. It was recognized at the Assembly meeting that these goals were unlikely to be accomplished in a one-year timeframe and would likely carry over to the next work plan.

<u>Sitka General Code 2.31.060</u> states: Annually, the commission will develop, identify, and present goals to the assembly for approval. The approved goals shall be the Commission's primary focus for the following year. Concurrently with presenting goals to the Assembly, the commission will submit a report to the Assembly on progress towards the previous year's goals and other activities which were approved and directed by the Assembly.

The <u>Sustainability Commission</u> Bylaws Article VI. Section A. Annual Work Cycle outlines suggested dates to begin discussion and planning related to the different phases of work the Commission conducts to remain in sync with City operations.

### <u>Analysis</u>

Two trends in the kinds of projects have emerged since the Commission's establishment, project based and operational based. Project based goals are time bound, often require some sort of monetary support, and require a significant level of Commissioner and staff time. Operational based projects are more rooted in the formulation of municipal policy and advisory group charters, etc. that furthers progress towards Resolution 2022-18: Decarbonize City Operations by 2030 and do not necessarily have a time limitation. These projects often come by request of City Staff and are not quite as visible, but their longevity is clearer as they can directly impact day to day municipal operations.

The 2022 final priorities list from the Climate Action Task Force are enclosed to further inform Commission discussion.


### **Recommendation**




